Together SF Action (Devin McAndrew-Greiner and Jordan DeAngelo)

- Together SF is a 501c3 organization. Together SF Action is a 501c4
- Together SF Action is meeting with neighborhood groups to discuss 2 charter amendments for the November ballot.

- The first is to reduce the number of commissions in San Francisco. Currently, there are 130 commissions. These are unelected positions and have governing power. The goal is to reduce the number of commissions to 65.
- The second amendment would seek to allow the Mayor's office to take decisive actions, and to add a deputy mayor. Their stated goal is to restore accountability to voters.

- After board discussion it was decided that we will not endorse them but if their proposals
 make it to the ballot for November, we will consider having them present at the October
 quarterly meeting, where pros and cons of ballot initiatives can be presented.

Grants:

- There are four 2024 projects seeking funding:
 - 1. Arlington Path Pollinator Garden (water meter \$1200)
 - o 2. Glen Park School (Kinder Yard beautification \$1000)
 - o 3. Sunnyside Elementary School (The Ray lit mag \$1500)
 - 4. Dolores Huerta Elementary School (Dream Library renovation \$1500)
- The total amount requested is \$5200. The amount we agreed to offer this year is \$5000.
 After discussion it was proposed that we change the amount offered to \$5200. Kevin moved, Steve 2nded. Two opposed. MSA Elena moved that we fully fund all 4 grants. Steve seconded. MSA

Green Infrastructure Grant Proposal (Nicholas)

- Nicholas is requesting a letter of support from the GPA for the grant application and project.
 - SFPUC Green Infrastructure Grant Proposal
- The grant is for property owners to install green infrastructure / rain gardens so excess water can trickle into the sewers instead of flooding into the sewers. There will be a big benefit downstream and will prevent flooding. This is an expensive project to construct. Property owners must maintain the system for 20 years.
- Heather moved that the GPA write a letter of support to SFPUC. Kevin seconded. MSA Nicholas to provide suggested wording.

Halloween (Elena)

• Elena has offered to organize the Halloween Chenery St. closure again this year. She will contact Supervisor Mandelman's office about funding.
